Happy mid-winter to all.

I am pleased to inform Club members we have a signed 2025 Partnership Agreement with the Alpine County Chamber of Commerce to co-market the Death Ride Training Series with the Death Ride. Death Ride participants can no longer directly sign-up for the Training Series on the Death Ride Registration portal; instead, interested riders must click on the "link" to the separate Training Series Registration site. This is not the optimal approach for maximizing participants for our Series, but we're hopeful a \$30 Coupon towards registration will stimulate interest. We're offering 5 rides at 2 week intervals beginning May 3rd:

Even though the Nevada flag did not fly on their journey across the United States, it is now making the rounds abroad. Just goes to show a little good will can go a long way. In this instance, about 5,000 miles!

Meeting called to order at 6:03 pm

1. Monthly Status Reports:

- **Treasurer:** The current checking account balance is \$11,724.97. The Paypal balance is \$11,112.52. CDs are currently at \$10,093.49 and \$10,310.10. Bill reported that the discrepancy he flagged at the December meeting was resolved. We may need to dissolve the 3 month CD when it comes to maturity at the end of February.
- **Membership:** There was a single new membership to start the year. Michael is working to reset the system for 2025 and will coordinate with Allen once it's ready to begin processing memberships.
- **Weekend Rides:** Weekend rides are on hiatus for the winter.
- **Weekly MTB Rides:** Conditions are actually good right now but Tuesday night rides won't resume until the spring.
- **Social Media:** No updates.
- **Newsletter:** Next newsletter will follow the February board meeting.
- **Website:** Greg is working on updating the MTB portion of the website.
- **Insurance:** The general liability policy and directors and officers policy must be renewed for 2025 before the end of January. Bill reported that he has renewed the club's LAB membership so that the insurance can be renewed. Michael will be on the annual LAB insurance conference call on January 15 when the new rates will be announced. Michael will also be working with the LAB insurance program managers to work out the details for DRTS insurance, and get quotes for renewing other

policies. Michael will circulate the details of the insurance purchase that need to be authorized so all Club officers need to be prepared to quickly respond to that email around the last few days of the month.

- **Clothing:** Michael will contact Ascend to check on lead times for new art and production time relative to the spring party.
 - **Weekly Road Races:** Joseph announced that Tony won't be able to help out as assistant race director for 2025 due to work commitments. Joseph's plan for the 2025 season is for the first race to be staged April 17 with 20 races and no break for July 3 which would wind up the season on August 28. Joseph is working on the technology to program the new chips he acquired so that we should have enough chips for every category.
 - **Junior Team:** No Update.
 - **Cyclorama:** No Update.
 - **Fall Century:** Still tentatively planned for first weekend in October.
 - **Adopt A Highway:** Jordan is looking forward to getting dates out for this year. When the club calendar draft comes out he will get them set and wants to have a Saturday date on the calendar.
 - **Training Series:** Bruce reported that the Chamber has not responded to the proposed DRTS agreement. It was agreed that plans for a possible DRTS for 2025 will remain on hold until the Chamber makes a decision. It was agreed that Bruce shall be empowered to execute the agreement if and when the Chamber does so.
2. **2025 Club Calendar:** Michael is working on the 2025 club calendar. It was agreed that the March board meeting will take place on March 8, the April board meeting will take place on April 8. We'll kick off the 2025 season with the Spring Party on April 10 and the Spring Rider Roundup on April 12 with the MTB rides, Thursday races, and weekend rides starting the following week. Michael will check with the Town of Minden on CVIC availability and will distribute a draft of the 2025 calendar.

Meeting called to order at 6:01pm

Minutes of the January meeting approved as presented. [Allen | Bruce | Unanimous]

1. Monthly Status Reports:

- **Treasurer:** GNCU statement for January not available at the time of the meeting. The current checking account balance is \$4,493.86. The Paypal balance is \$2,314.70. The CDs are currently worth \$10,857.55, \$20,466.90, and \$10,257.86. The CD expiring in February will be rolled into the checking account.
 - **Membership:** With the insurance renewed for 2025 we can update the membership waivers and get the membership renewal system back online over the next couple of weeks.
 - **Weekend Rides:** No rides for the 2025 season yet. Lyn is planning to schedule a ride leaders meeting.
 - **Weekly MTB Rides:** Chris reported that the Clear Creek trail was clear up to the bridge but no club rides are scheduled until April.
 - **NICA Team:** Coaches and team directors met recently to decide on new team leadership. Timari Pruis will be taking over as team director from Greg Philips. Geoff Blachman will take over as head coach. The team hopes to expand the level of participation from Douglas HS and plan to have more practice meetings in Carson Valley.
 - **Weekly Road Races:** Joseph wants to skip July 3 so this will extend the race schedule to 21 weeks. Joseph is still looking for an assistant race director. The [software vendor] is writing new code specific to our chip reader that will allow us to program our own chips. Bill suggested some new venues for consideration.
 - **Insurance:** Michael reported that D&O and GL insurance for 2025 has been purchased. We still need to decide on \$1M in excess coverage (\$750), non-owned auto insurance coverage (\$874.00) and event insurance (\$519 minimum, \$14.47 per person). Agreed that we will purchase the event insurance and excess coverage if and when the Chamber signs the agreement [Bruce | Michael | Unanimous]. Board members will check with their insurance companies on prudence of auto coverage
 - **DRTS:** Need additional leader(s)/coaching volunteer(s). It was agreed that full price for the series will be \$220 which will be discounted with \$30 coupons broken out as \$50 plus \$30 for each of the first three rides and \$40 for each of the fourth and fifth rides [Bruce | Michael | Unanimous].
 - **Adopt A Highway:** We will be doing three adopt-a-highway events in 2025. Members are reminded to wear close-toed shoes and bring gloves. Jordan will confirm dates on the calendar.
 - **Social Media:** Please email items to Michelle.
 - **Website:** Greg added MTB pictures and is working to add Google analytics. He also removed outdated content and is getting ready to add the 2025 club calendar.
 - **Clothing:** There are no sales from inventory to report. Ascend reports that they have a seven week lead time on new jerseys. The consensus was that we should open our ordering window to aim for jersey delivery in time for the Cyclorama in May.
 - **Newsletter:** Release planned for next week so please get everything to Michael by Friday.
 - **Spring Century:** No update.
 - **Fall Century:** No Update.
2. **Calendar:** Agreed on Spring Party for April 9. Michael will make the booking. Michael will also check for availability of CVIC for the planned November 3 annual meeting.
3. **Next Meeting:** Monday, March 3, 2025, 6 pm, by Zoom.
